Elon Musk will support Dr Kulvinder Kaur's legal battle

Last week we reported that Dr Kulvinder Kaur Gill, the courageous Canadian physician was facing financial hardships and bankruptcy as a [heavy fine of \\$300,000](#) was imposed on her due to her strong opposition of the harsh measures to control the pandemic. In a happy turn of events, [Elon Musk has pledged](#) to support her cause. Dr Kulvinder Kaur Gill is a practicing physician in Canada specializing in paediatrics and immunology.

UHO feels that this move is a critical one for salvaging science and democracy which got suppressed by [power, politics and corruption](#) since the beginning of the pandemic. This could be a turning point in the free fall for humanity since the beginnings of the pandemic. If other billionaires follow suit and emulate Elon Musk, we may reach the tipping point and the tide may turn.

World Renowned Oncologist Angus Dalgleish worried about unusual flaring up of cancers

Dr Angus Dalgeish, Professor of Oncology at St George's Hospital Medical School, London, [reported](#) that last year he was seeing melanoma cases which had been stable for years flare up after receiving the Covid-19 vaccine boosters. He was informed that these were just coincidences and advised to keep quiet. But he confessed that when he saw more such cases it was impossible for him to keep it to himself. What raised his concerns further was that other cancer specialists were approaching him from other parts of the world with similar observations not only confined to melanomas but other cancers as well such as lymphomas, leukemia and kidney cancers all of them showing relapse after the booster Covid-19 jabs. Professor Dalgeish has called for immediate halt of the Covid-19 vaccines.

UK Physician Dr Philip McMillan calls for proper research on future UK Queen's cancer diagnosis

Relevant in the background sudden rise in incidence of cancers, particularly among young people, Dr Philip McMillan, a physician in the UK, [suggested](#) more research around the cancer which has afflicted Kate Middleton, the future Queen of UK. He rues that such research is not being pursued. On the other hand, all efforts are being made by the scientific community to distract attention from the "elephant in the room," i.e. the Covid-19 vaccines. He described a [study](#) from Northern Ireland which tries to achieve this by presenting data which shows a 20% rise of cancers in young people between 1993 and 2019. He wonders why the study did not present data for the period 2019-2023. Such type of selective reporting, McMillan says, will divert attention from the role of the Covid-19 vaccines, if any, in causing unusual rise of cancers

FDA in the USA loses Ivermectin case, asked to remove warning about its use in Covid-19

In a landmark ruling that has relevance for the [legal notice served](#) to Dr Soumya Swaminathan the former Chief Scientist, WHO, by the Indian Bar Association for her tweet denouncing Ivermectin for prevention and treatment of Covid-19, the US Court [ruled](#) that the US Food and Drug Administration (FDA) had extended its brief in cautioning the people on use of Ivermectin. After losing its battle in court, the FDA has agreed to remove the WebPages on its site carrying misleading warnings such as "Ivermectin is a drug for horses and you are not a horse," and other messages urging people not to use Ivermectin for prevention and treatment of Covid-19.

Anti-TB drugs in short supply in the country: Patients, Public Health Activists approach the PM

Slogans and propaganda do not work against disease. We have witnessed populists slogans like "Corona-Go" accompanied by banging of thalis and lighting of diyas. Similarly, the slogan "End-TB by 2025" will remain an empty slogan without any impact on the TB burden in the country. TB is a far greater public health problem, many times more than Covid-19, if the latter can be called a public health problem, that is. Daily over [1400 lives are lost from TB](#) in the country, far more than the fatality from Covid-19.

While the government's call is "End-TB by 2025," its action shows apathy. This is reflected in the crisis of availability of anti-TB drugs in the country. This has forced TB patient, HIV patients with TB co-infection, doctors and activists to [write to the PM and the Health Minister](#) to resolve the crises. The letter has been endorsed by over 50 organizations and individuals and has appealed to the PM to take urgent action to restore uninterrupted supply of anti-TB drugs.

UHO also seconds this call and recommends that our public health policy makers should assign public health priorities customized to the diseases which higher morbidity and mortality in the country, instead of adopting public health priorities from the West which has a different disease and demographic profile.

For instance, during the so called Covid-19 pandemic, resources were diverted from our TB control program to Covid-19 control a far less lethal disease given our young population. This has pushed back our End-TB goal by a couple of decades. And now with the shortage of anti-TB drugs, one wonders whether our visionary PM will again give a call to the people to "bang thalis and light diyas" chanting "TB-go, TB-go!"

Universal Health Organization (UHO) issues an open letter calling for debate on the appropriateness, harms and accountability resulting from the interventions during the Covid-19 pandemic

A true scientist is a seeker of truth, always welcomes debate and discussion on complex issues, and never afraid of being corrected if proved wrong. All others are practitioners of dogma. It is said that one should admire the person in search of the truth but beware of the person who has found it!

Given the motto of “Transparency, Empowerment and Accountability,” on the fourth anniversary of the lockdown, [UHO published an open letter](#) addressing all academicians, scientists and doctors to an open and healthy debate on the topic, “Lockdown ‘total failure’ of science more than of politics.”

The letter also touches upon the Kerala Public Health Bill and the looming WHO Pandemic Treaty and how these will encroach upon human rights. It calls for debate and accountability on the scientific basis for lockdowns, social distancing, school closures, need for vaccinating those with natural immunity, ethics of mass use of vaccines which have not completed clinical trials, the adverse events following immunization (AEFI) system in the country, long term safety of the vaccines, the reliability of the rt-PCR tests, and asymptomatic transmission.
